Manager's Report

Michelle stated that as of May 24th, we have received \$187,721.13 in Association Dues for 2018. 834 homeowners have paid their dues; this time last year 835 homeowners had paid. The credit card statement, security times, and utilities spreadsheet can be found in the Board Packet. The renewal of the workers comp insurance can be found in the Board Packet. The renewal this year is \$1,277; last year we paid \$1,271.00. We are still gathering the information on the tree services/main water line. VSC came out and looked at the security cameras and believe that the cables were smashed somewhere because when they tub on the lines; it gets stuck. I have sent an email to Jeanne for clarification on the collections resolution but have not received a response.

Treasurer's Report

Robert stated that there is a negative net cash flow since we have not received some of the dues.
